Location

Clapham Road is located in Lowestoft, Britain's most easterly town, and just a 10 minute walk from the town centre. Lowestoft is best known for its picturesque seafront, with its sandy beaches and seaside amenities including the Victorian seafront gardens, the Royal Plain Fountains and two piers. The town is also well served by a good selection of shops, eateries and services. Close to the property is the Waterlane Leisure Centre and Lowestoft Football Club. There are also numerous schools within the vicinity. The area is well-connected by public transport, with nearby bus stops providing access to other parts of the town and surrounding regions. Lowestoft also benefits from a railway station, offering regular services to Norwich and the surrounding areas.

Description

201 Clapham Road is a Victorian mid-terrace house with colour washed elevations under a pitched tiled roof.

A front door opens into the entrance hall which has a door off to the sitting room and stairs to the first floor landing. The sitting room has a window to the front. A further door from the entrance hall leads to the dining room, a light room with French style doors to the garden, and with an understairs cupboard. An opening from dining room leads to the galley kitchen, which has a window to the side, a range of fitted wall and base units and space for appliances. There is a door to the ground floor bathroom which has a panelled bath, mix tap over and shower attachment, pedestal handwash basin with mix tap over and closed coupled WC. There is also a window to the side and the rear.

From the first floor landing there is a door off to bedroom one, a double bedroom with a window to the front. Bedroom two is a further double bedroom with a window to rear, an automatic gas fired boiler, and built-in wardrobe. From bedroom two there is a door with step down through to bedroom three, with window to the side.

Outside the property has a small front garden. There is also a gated side access to the rear garden which has concrete hardstanding and a further secluded terrace behind fencing. There is also a timber shed.

There is a right of way in favour of 203 Clapham Road North, immediately to the rear of the property for access.

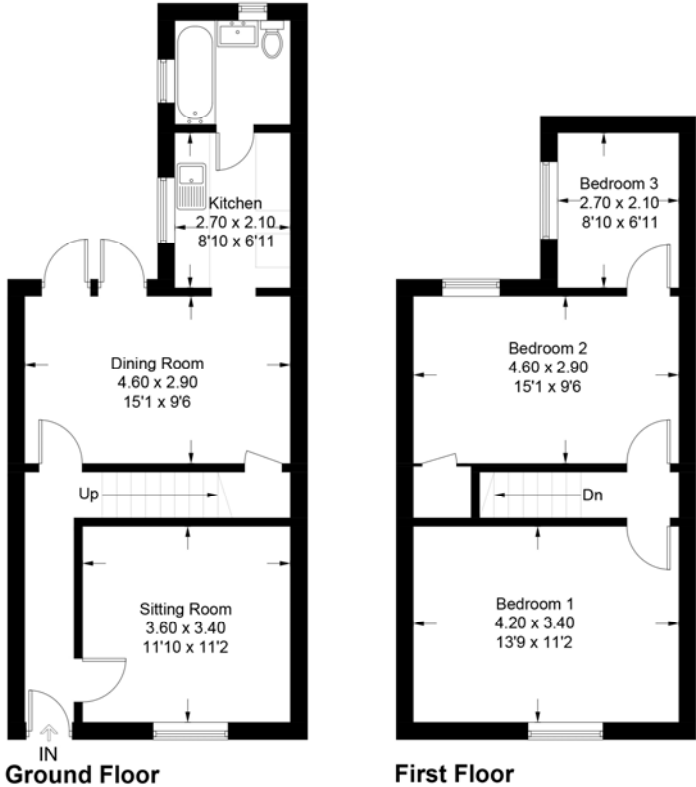






201 Clapham Road

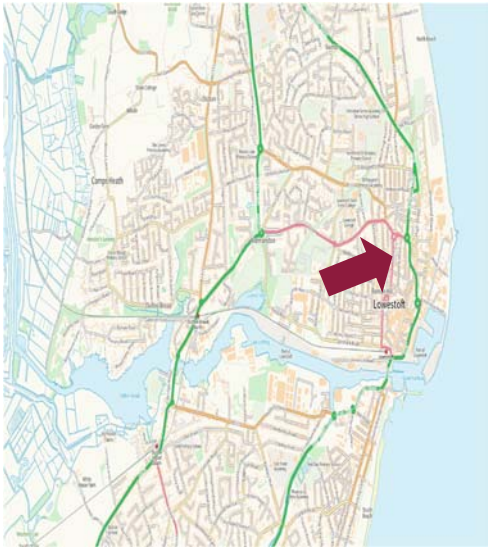
